Rule application and other conditions of LATAM Airpass

Eligibility: LATAM Airpass: Account Code "LATAM"

Class of Service: Fare Bundle Full: L & H Premium Economy: W Premium Business: D

** Bundle Full identified by the farebasis EOPPSAA for all routes by the exception of Domestic Brazil.

For Domestic Brazil routes, Bundle Full is identified by the farebasis EOP7SAA **

Travel restrictions: valid for trips starting from February 7th 2024 and ending before/on December 31st 2024

Sales restrictions: tickets must be issued before December 31st, 2024. May only be sold outside of South America.

Advanced reservations/ticketing: Confirmed reservations are required for all departments. When the reservations are made at least 30 days prior to departure, issuance must be made at least 30 days prior to flight departure. For reservations made less than 30 days prior to flight departure, GDS co either issuance must be made within 24 hours following the reservation being made or at least 24 hours' prior departure, whichever happens first.

Taxes: Domestic flights within Peru will be subject to government taxes. You can apply for exemption from these taxes by entering the LATAM international ticket number in the endorsement box to avoid receiving debit memos.

Taxes: Validate in the GDS, given that each country has its regulations. Airport departure taxes are not included and must be collected at time of issuance.

Coupons: minimum of coupons 1. Max. 16 coupons, including surface. The same segment may only be flown once in the same direction. Allows surface.

Rule Application

Applies to non-resident passengers in South America traveling with an international ticket to and f rom South America on flights operated and marketed by LATAM. Or in connection with an international flight between Spain and Peru/Ecuador marketed and operated by Iberia (IB)

Passengers holding an international ticket issued outside South America with LATAM Pass arriving and or departing are also eligible for the LATAM Airpass. Passengers being compensated also qualify. With ID/AD tickets do not qualify for South America Airpass. Tickets must only be sold outside of South America.

Ticket Endorsement: Tickets must be issued in connection with an international ticket, operated and marketed by LATAM, to and from South America, or in connection with an international flight between Spain and Peru/Ecuador marketed and operated by Iberia (IB).

Please note the correct and complete international ticket number must be inserted in the endorsement box. Failure to do so will be subject to ADM.

Endorsement box: 'conx. <intl. Tkt>non-end/non-ref/chg fee applies/conx.

Endorsement is not necessary for Domestic Colombia and Domestic Ecuador markets, where they are allowed to be issued separately, without a LATAM international flight.
